Council Meeting Notes – December 14, 2025

November Council meeting minutes were read and approved. November treasurer's report was presented and approved.

Pastor's & Board of Elders' Reports

- No reports today.

Board of Education Report

- \$3590 non-member tuition was received during October. That comes to \$10,564 of \$43,044 for the 2025-2026 school year.
- The substitute teacher policy has been clarified. A substitute teacher will be paid for a minimum of ½ day at the substitute rate.
- Christmas treat bags for children will be prepared.
- The students are learning to use the new computers.

Board of Trustees' Report

- The Trustees not planning to contract but deal with the mice themselves.
- Kevin suggested that we have someone make sure that the parsonage walk to the mailbox is shoveled.
- Trustees are planning to install the drinking fountain during Christmas break.
- Dale and Rick have prepared 3 signs to remind neighbors that children play on our playground and the area is not for dogs.

Other Business

- Motion approved to set fair market value of the parsonage at \$850/month.
- The nomination slate is complete and will be put in the bulletin.
- The Dorcas Guild declined the council's request to maintain the name and address information in the Realm system. There are people that have offered to help with this. Dale will speak with these volunteers.
- Dale said that it is possible but not easy to opt out of participation in the Minnesota Paid Leave process, so he is recommending that we do the things that are required by that legislation. Phil reported that our taxable wage base for 2026 is \$185000. The premium would be about \$1620 in 2026. There would be a fee to opt out and there would be a requirement to get a surety bond through an insurance company to demonstrate that we could make the required leave payments. Phil is set up as an administrator on the paid leave website. Dale will also become an administrator on the site.
- Brian and Ellen provided 10 Windows 11 computers to replace the Windows 10 workstations.
- Motion approved to purchase 2 server computers to replace the current 2 servers that are currently running unsupported Microsoft operating systems through Brandon for about \$1500.
- Kevin explained how he is getting confirmation instruction materials from Pastor.
- Phil has a draft of an investment policy doc that he will share with the Council.

General Fund – With a large dollar amount of contributions received in November, the deficit in the fund has almost been eliminated! Praise be to our Lord for moving the hearts of His people.

ILC Operations –Although revenues were less than disbursements in the month of November, we are still ahead of last year at this time with a balance of about \$92,000.

Church Extension Fund – Year to date revenue consists of payments received of about \$132,000 from congregations on the loans they owe the CLC, and almost \$124,000 from increases in the market value of the investments. Disbursements include just over \$485,000 loaned to a member congregation for their building project.

Other Auxiliary Funds – The activity in the other funds in the table above is similar to the activity in the same period a year ago.
