WHOSE ARE THE CHILDREN?


According to *WorldNetDaily* (3-1-08) "a California court has ruled that several children in one homeschool family must be enrolled in a public school or 'legally qualified' private school ..." In what is the height of sophistry the court said, "We agree ... 'the educational program of the State of California was designed to promote the general welfare of all the people and was not designed to accommodate the personal idea of any individual in the field of education.'" Their argument that the educational program was not designed to accommodate the personal idea of any individual in the field of education appears to be aimed at the parents of the homeschooled children, who in this case object to the "various anti-Christian influences" in the public schools of California. We might well agree that we do not want the personal idea of any individual promoted in the public school. But we can make a good case that the only personal ideas they want to quash are those of individuals who take seriously what God says in Deuteronomy 6:6ff and Ephesians 6:4 and speak from a Christian perspective! The state's sophistry is compounded by a lie. The systemic religion of public education – we are speaking of the system, not teachers as such – is secular humanism, a world view that in its rejection of Christ and divine truth is totally this "world-centered."

The issue is not whether children should be educated by *qualified* teachers. We appreciate committed teachers who have prepared for their profession, and who teach the subject at hand. But neither do we buy the idea that simply because someone has a certificate issued by the state he is necessarily a qualified teacher. Further, when the schools go beyond teaching the essentials and become thought manipulators through teaching of evolution, promotion of alternate life styles, and purveyors of political correctness, and finally through word or actions deny the expression of, or ridicule "sincerely held religious beliefs" of Christian parents, the same Christian parents are confronted with a decision. We are to obey in all things (Romans 13) unless we are asked to sin. Acts 5:29 says, "We ought to obey God rather than man," in such circumstances. Each one will have to determine for himself whether the issue at hand rises to such a level.

Under the law we are free to seek redress. The California parents are considering taking their case to the Supreme Court. If the court upholds the parents right to homeschool their children, fine and good. If not they are confronted with another decision, which could mean suffering the consequence if they are conscience bound to resist. We know that in this world we shall suffer persecution (2 Timothy 3: 12).

But we as Christian parents, grandparents, and congregation (in that order), have no ground of complaint if, whatever the circumstances, we are not regularly and faithfully exercising our responsibility to train up God's children in the fear and admonition of the Lord. Whether they are in school or homeschooled they are confronted in daily life on the street, in the press, and on TV with Satan's devices that overtly or covertly entice them away from the Word of God, from their Lord and Savior, and into "despair and other great shame and vice."

Training children up in the Lord begins in the cradle. At the head of each chief part of Christian doctrine in the catechism Martin Luther wrote, "As the head of the family should teach it in a simple way to his household." The Church and its agencies- eg. Sunday School, Christian Day school- are not appointed to replace parental responsibility, but to *assist* parents in the task of instructing children of the Heavenly Father in the Word, and in appreciation of the grace of God in Christ Jesus. Furthermore the example we set by our own worship life, and the devotional priorities in the home, as well as in our daily life is the best "homeschooling" that we can do. God forbid that we should ever lose that right! To possess it and to waste the opportunity is not criminal before the civil law. It is sin before God!



Scripture tells us that in the last times there will be a falling away. It will become more and more difficult for the Christ believer to confess the truth without fear of reprisal. More and more the state is trying to intrude into our homes and schools to make wards of our children. Therefore it is our responsibility not to waste a moment in bringing the Word to our children, *and the children to the Word* for a number of reasons: 1) so that by the Gospel they grow in faith in the Lord Jesus Christ, their Savior in whom they can find comfort in the difficult days that lie ahead 2) so that they may live in confidence of forgiveness and eternal life, and 3) so that when they are confronted by the devil's wiles they have the spiritual discernment to recognize them.

The court decision is a politically and socially driven action that impacts parental responsibility. It bodes ill for parents who choose to raise their children according to the dictates of their conscience. But let us not simply lament the direction we are headed, but as responsible Christian parents, grandparents and congregation (in that order) raise up our children in the home so that as they know Christ and know that they are known of Him, they can face the future with the Savior's promise firmly implanted in the heart: "My sheep hear my voice, and I know them, and they follow me: And I give unto them eternal life; and they shall never perish, neither shall any man pluck them out of my hand. My Father, which gave them me, is greater than all; and no man is able to pluck them out of my Father's hand" (John 10:27-29). No one shall be able to rob them of faith, and of the Savior's embrace as they grow in and continue in Christ Jesus - not government schools, not society, not the law, not the government!



"Ye therefore, beloved, seeing ye know these things before, beware lest ye also, being led away with the error of the wicked, fall from your own steadfastness'. But grow in grace, and in the knowledge of our Lord and Savior Jesus Christ-" (2nd Peter 3: 17), you, and the children for whom God has made you responsible!
