## **RETAINING YOUR RETIREMENT:**

At this writing, the economy is in a hard way. It has been for some time. Financial fear and instability is stoked by the huge national debt, the unemployment figures, the wildly fluctuating market, as well as the inability to deal with the problems. Many citizens are concerned, concerned about the national debt to be left to their children and about the stability of their personal retirement kitty.

There are many reasons for the present circumstances. We do not pretend to be an economist or even very financially astute. But we know this much: if we spend more than we earn, and increase debt beyond our ability to pay, we are in trouble.

But instead we prefer to direct attention to the spiritual parallels and recognize from Scripture that in this age of increasing hopelessness and ever changing circumstances, the child of God has hope because of a change that took place — a change that is unassailable.

With the entrance of sin into the world through Adam, the peace, health, confidence, and life of Eden were lost. Ever since, mankind has been in debt to God! Unlike the financial condition in the world in which men turn for a solution to the very ones who created the problem, the Heavenly Father took it upon Himself to fix man's sin problem. He sent the Debt-Payer, the Lord Jesus Christ, into the world. Through His death on the cross Jesus paid our debt. He paid it completely. He said, "It is finished" (John 19:30). Your debt, my debt, the debt of all sinners is paid! The Father, Who in Christ reconciled the world unto Himself (2 Corinthians 5:19) confirmed the payment by raising the Lord Jesus Christ from the dead! For our salvation He asks nothing—nothing!—of us but that we believe in His Son, and rest in His promises. So much for the debt problem!

Further, the Father sent the Spirit of God as the guarantor of the blessings that accrue to mankind from the cross of Christ. The Spirit works the faith whereby we believe that the Father has qualified us to be partakers of the inheritance of the saints in light (Colossians 1:12). By the grace of God, the believers place with the saints in heaven is secure through Christ "in Whom we have redemption through His blood, the forgiveness of sins" (1:14).

Holy Scripture tells us that we have an inheritance in heaven. For our purpose here, let us call it retirement security. "Blessed be the God and Father of our Lord Jesus Christ, Who according to His abundant mercy has begotten us again to a living hope through the resurrection of Jesus Christ from the dead, to an inheritance incorruptible and undefiled and that does not fade away, reserved in heaven for you, who are kept by the power of God through faith unto salvation ready to be revealed in the last time" (1 Peter 1: 3 -5).

Retirement or pension funds in this life are to a great extent funds into which we must contribute. One of the factors contributing to the current financial woes in the country, however, is that some citizens expect and demand the employer or the state fill one's retirement coffers, in some cases with a minimal, if any, contribution on the part of the individual beneficiary. Consequently employers, states, and even the nation are in financial trouble. They cannot guarantee the employee that they can continue to pay into the pension fund, or that money will be there upon retirement.

But how different with our heavenly inheritance! On one hand, we are in no position to demand an inheritance from the Father. On the other hand, the Father does not expect, or demand from sinners a contribution to the promised inheritance in heaven. He arranged for it and paid it through the sacrifice of Jesus! In Christ, "we have obtained an inheritance, being predestined of Him Who works all things according to the counsel of His will …" (Ephesians 1:11), all according to the riches of His grace!

Furthermore our inheritance in heaven is secure. Others cannot borrow from it, spend it, or otherwise abuse it. Each and every believer in Christ has an inheritance of equal value, equal length, and equal benefit. That inheritance is reserved and guaranteed without qualification by the blood and merit of the Lord Jesus, and the faithfulness of the Father.

Wise stewards of God's gifts will not misuse their material blessings, and to the extent possible they will look after their retirement years. But they will be equally careful to be in control of what they have put away, and not let their savings control them. They recognize that where their treasure is, the heart will be also (Matthew 6:21), and therefore will lay up for themselves, "treasures in heaven, where neither moth nor rust destroys and thieves do not break in and steal" (6:20).

The believer in Christ who sets "his mind on things above, and not on things of the earth," may indeed endure hardship, loss, and setback on this earth. He may even suffer financial destitution. It is not our intent to diminish the seriousness or the difficulties of such circumstances. But all who count heaven as their highest treasure can live in hope and in confidence that the heavenly inheritance is not and will not be diminished or lost for "When Christ who is our life appears, then you will also appear with Him in glory" (Colossians 3: 2, 4).

Blessed are they who believing the promises of the Father, whate'er betide, can sleep at night and rise in the morning in confidence of the Lord's invitation, "Come, ye blessed of My Father, inherit the kingdom prepared for you from the foundation of the world" (Matthew 25:34).
