

# "IN THE BEST INTEREST OF ..." the dog?

In a pet custody case, the Supreme Court in Vermont ruled recently that the husband in a divorce should get the dog "because it is in the best interest of the dog." There is nothing under the law that addresses this since, unlike children custody cases, a dog is considered property. So the judgment was rendered according to the judge's subjective opinion. The judge said that the husband treats the dog like a dog, while the wife treats the dog like a child.

We can't make this stuff up. There are many things that could be said by way of explanation of this judgment. But at the risk of offending animal lovers, we were pleased that the judge at least spoke of the dog as a dog, and did not equate the dog with a child. Nevertheless, the *terminology* of the judgment confuses the distinction between a four-footed animal, and a child with a soul precious to the Lord and for whom the Lord Jesus died.

As the crown of God's creation, humans are to appreciate all of God's creation. Such appreciation begins with recognizing that God *created* mankind both in manner and in purpose to be different from the animals. Humans were created in the image of God. Animals were not. Animals were created as "God said" (Genesis 1:19-25). Man was "formed of the dust of the ground" and God "breathed into his nostrils the breath of life; and man became a living being" (Genesis 1:7-8). Everything God created, including animals as well as mankind, was created with a purpose. Animals were created for the service of man, not the other way around.

Man first abused animals and all creation with introduction of sin into the world. Since that moment all creation was delivered into the bondage of corruption, and became subject unto death.

Appreciate the companionship of your pet. Treat it as a creation of God, all of whose creation is to be appreciated. But it says something about our society that we need to defend the proposition that there is a distinction between children who are offspring of their human parents, and animals who are offspring of other animals. To confuse man with animals is of course a staple of evolutionary philosophy which is prevalent in public education. It is also telling that in our society one can be prosecuted for destroying turtle eggs on the beach or maiming or killing a dog, but is not prosecuted for destroying children in the womb!

This brings us to the subject of what is in the best interest of our children. "In the best interest of the children" means different things to different people. For some it means no more than that the children be provided with the material necessities of life, and even such things as are nice to have but not necessary. It means providing them with a safe environment, good education, with opportunity to grow to be "all that they can be." Fine and good! There is nothing un-Christian in such desire. But for the Christian "in the best interest of

the children" is *much more*, and unless parents understand this, their children blessed with all the above and more are in fact a cheated generation for which parents are held responsible.

The best interest of our children begins by addressing their spiritual and eternal welfare! This means that parents appreciate that they are a gift of God and not an object to be aborted! From the moment of conception children are conceived and born in sin (Psalm 51:5) and are under the wrath of God (Romans 6:23a). Of the flesh, they are in the image of their parents (Genesis 5:3), not of God. So parents blessed with the birth of a child will bring their child(ren) to baptism that God by that means of grace may give them a new birth, and through this new birth write their name in the Book of Life and make them members of His Kingdom. Parents who understand their responsibility will faithfully bring up their child(ren) in the nurture and admonition of the Lord (Ephesians 6:4) because the Lord Who loves the child(ren) desires that they be nourished unto eternal life. That means that in this life parents will exercise proper and loving discipline (Proverbs 13:24). Children need to understand the law of God which uncovers sin and pronounces wrath upon the sinner. Loving discipline does not neglect, but gives the child(ren) daily Gospel nourishment whereby they know that they are loved of the Father, and are forgiven and redeemed by the blood of Jesus Christ. The Gospel assures them that whatever the circumstances in this life may be, in sickness and in health, they have a future and a blessed and better home in heaven with the Lord to which in God's time they will be taken. The Gospel puts their mind at ease as they learn that they are saved by grace through faith alone in Christ, whom as a consequence they desire to serve in righteousness and true holiness.

Looking after the best interest of the children means that parents will set their child(ren) an example of a godly life in the home, and in conduct. Such an example begins with faithful use of the Word in the home, as well as though faithful attendance around the Word and Sacrament with fellow believers in God's house. Parents will let their children know that the best education of all is found in God's Word, and that the best educational environment is where God's Word is the foundation of true wisdom.

Children should learn from their parents that he or she who lives and dies with the most toys still dies. He who lives and dies in faith in the Lord Jesus is blessed here in the waiting, after which he or she shall live forever in the blessed peace of heaven with the Lord.

The best interest of children is being served when parents focus on the spiritual and the eternal for their children. Such children are not deprived for God's word remains true: "Seek first the kingdom of God and His righteousness and all these things (necessities of life) shall be added to you" (Matthew 6:33).
