- ◆ Missionary Ude Resignation: After serving in foreign mission fields for more than eight years. Missionary Ude was led to resign his call as our full-time missionary to India and visiting missionary to several African countries. This decision was made after much prayer and months of discussion with the Board of Missions. His resignation was based on how the extensive travel and uncertain schedule required of his call would take him away from his God-given responsibilities as husband and father. Shortly after he formally announced his decision to resign to the Board of Missions, his daughter Kaylee became very ill and has since required several brain surgeries and extensive treatment in Marshfield, WI. Missionary Ude made an emergency return to the U.S. and will remain until he feels the time is appropriate for him to return to India to tie up some loose ends along with packing and shipping their belongings back home. The nature of Kaylee's medical condition will require expert medical oversight and probably more surgeries over the next few years. Missionary Ude will continue working on Board of Missions projects and correspondence and will receive salary and benefits until the end of 2016 unless he is led to accept another divine call or decides to pursue secular employment. The Board of Missions is extremely thankful to the Lord for Missionary Ude's many gifts and faithful service to the mission fields where he and his wife Vanessa have selflessly served for the sake of our Savior's kingdom. With prayers for their daughter Kaylee's health, and knowing that our God is good, gracious, and full of mercy, we are confident that He has a great plan for their family, to give them a future and a hope through our Savior's death and resurrection.
- ◆ Myanmar Earthquake: Please include prayers for our brothers and sisters of the Zomi Lutheran Church of Myanmar (ZLCM). A 6.9 magnitude earthquake recently hit the western regions of Myanmar where several ZLCM congregations are located. Pastor Kham reported that among the congregations of the ZLCM, three members were killed, seven were hospitalized, and five homes were severely damaged. When the HCLC-Nepal heard about the earthquake in Myanmar, Pastor Raju Bhitrakoti called and requested that some of the remaining funds from the Nepal Earthquake Relief Fund be sent to the ZLCM as soon as possible to assist them in their time of need. Money was sent from the Nepal Earthquake Relief Fund to the ZLCM this past week and no special offering will be needed at this time. In addition to the recent earthquake, there has also been recent flooding and wind storms in western Myanmar. Please pray for our brothers and sisters in Christ of the ZLCM as they struggle to recover, continue to pray for members of the Himalayan Church of the Lutheran Confession in Nepal as they work to rebuild, and give thanks and praise to the Lord for compassionate and willing hearts that are led by our Savior's love to help our fellow Christians in times of need.

TRIVIALIZING THE BIBLE—GOD'S BOOK

The Bible is the sixth most-challenged book on a list of challenged and banned books. The reasons for this are many, not the least of which is the content. Challenging the Bible for its content speaks to the ignorance and disrespect such challengers have toward the Lord God and His inspired Word.

On the other side of the ledger state legislators in Tennessee are trying to make the Bible the state book. They passed such legislation "in order to recognize its significance from a historical, economic and cultural standpoint." To his credit, the governor who professes to be a Christian vetoed the bill. He said, "My personal feeling is that this bill trivializes the Bible which I believe is a sacred book." He also did so citing constitutional grounds. (1) As the American Civil Liberties union (ACLU) also opposes the bill, though not out of respect for the Bible, we find ourselves in strange company with an organization with which we disagree on most issues.

Confessing Christians equate the Bible with Holy Scripture. In *all* subjects it addresses, it is *truth*. In His high-priestly prayer, the Lord Jesus asked the Father to sanctify His disciples through the Word, saying, "Your Word is truth" (John 17:17). Further, when Jesus gave the commission to go into all the world, He told the disciples to go "baptizing them in the name of the Father and of the Son and of the Holy Spirit, teaching them to *observe all things* that I have commanded you ..." (Matthew 28: 19-20). It is doubtful those who want to make the Bible the state book, would subscribe to that instruction of our Lord.

Such legislation as is proposed, the veto of which legislators will seek to overturn, diminishes the Bible to the level of a book authored by fallible men. It fails to recognize that the Bible is different from any other book in respect to its authorship, its subject matter, and its message and purpose. It suggests the Bible is just another philosophy book, and makes it merely a book of rules and regulations. It makes of the Bible a political tool. The Bible is made a window dressing.

Authorship: The Bible (Scriptures: writings) does not *contain* the Word of God; that is, it is not sprinkled with the meanderings and opinions of men within which God's Word is found. It *is* the Word of God. While it has many writers it has *one Author*. "All Scripture is given by inspiration of God," that is, it is God-breathed (2 Timothy 3:16). "Holy men of God spoke as they were moved by the Holy Spirit" (2 Peter 1:21). The apostle Paul declared, "These things things we also speak, not in words which man's wisdom teaches but which the Holy Spirit teaches ..." (1 Corinthians 2:13). Again "... when you received the Word of God which you heard from us, you welcomed it not as the word of men, but as it is in truth, *the Word of God*, which also effectively works in you who believe" (1 Thessalonians 2:13). Apart from the claim that the Bible declares itself to be the Word of God—and this truth stands by itself—it is nevertheless interesting that in spite of the prideful ego of the human heart, nowhere in the Bible is there any envious claim by any writer to be the author of what he has written. The Bible is the Word of God.

Subject matter: The Bible is His-Story. It contains the history of which God is the Author from the creation of the world to the end of the world. It speaks to the reader of the providential care of God over all that He has created. It declares the will of God for mankind. Consequently, the two great doctrines(teachings) of the Bible are *Law* and *Gospel*. The Law tells us what to do and not to do. It shows us our sin (SOS). It shows us our condemnation for transgressing the Law (SOC). On the other hand, the Gospel shows us our Savior from sin (SOS).

The focal point of the Old and the New Testaments is the Lord Jesus Christ and eternal life. All who truly understand the message and purpose of Scripture see that the Bible is unique.

Message and purpose: It is difficult to separate message and purpose. These speak to the very definite reason for which God gave and preserves His Word to us.

When God created mankind, He intended only the best for him, a life of bliss and joy forever. By sin man lost what God intended. But because the Lord God is good and gracious, He desired to save guilty mankind from the death he brought on himself. He promised the Savior from sin Who would destroy the power of the devil (Genesis 3:15) and restore life and immortality. This Jesus did by His perfect life as well as by the death He endured in our place. But death could not hold Him. He rose from the dead and restored to us the life in heaven that God intended for man before the fall. This speaks to the purpose of Scripture: "From childhood you have known the Holy Scriptures which are able to make you wise for salvation through faith which is in Christ Jesus" (2 Timothy 3:15). And again: "These are written that you may believe that Jesus is the Christ, the Son of God, and that believing you may have eternal life in His name" (John 20:31). Jesus said, "I have come that they may have life, and that they may have it more abundantly" (John 10:10). This is *not* a social gospel reference. The abundant life is that which Christ-believers shall enjoy in heaven.

While we live on the earth, and await the deliverance to glory, it is the will of God that we serve Him. It is our duty "to thank and praise, serve and obey Him." (2) Since this is not possible of ourselves in the flesh, Jesus prayed for His disciples and for us that the Father would sanctify His own by the truth (John 17:17). He has left us with His Word as a lamp to our feet and a light to our path. (Psalm 119:105). This speaks again to the purpose of Scripture which is inspired by God. It "is profitable for doctrine, for reproof, for correction, for instruction in righteousness, that the man of God may be complete, thoroughly equipped for every good work" (2 Timothy 3:16-17).

It is God's will that His name be glorified in the world. This is the will of the regenerate whom God has delivered from death and the power of the devil. God's people do not envy the Lord the glory to which He is entitled. He has redeemed us that we "may be His own, and live under Him in His kingdom, and serve Him in everlasting righteousness, innocence, and blessedness, even as He is risen from the dead, lives and reigns to all eternity." All this He has done for us "that in all things God may be glorified through Jesus Christ, to whom belong the glory and the dominion forever and ever" (1 Peter 4:11). In the Lord's Prayer we gladly confess, "For Yours is the kingdom, the power, and the glory, forever and ever. Amen."

This is quite a different understanding of the Bible than those who see it as just another book among many, albeit better than any other. It is quite different than a book recognized for "its significance from a historical, economic and cultural standpoint." The Bible, the Word of God, is not a political handbook!

We pray that government at whatever level will keep its hands off "God's book" and not use it for political ends. At the same time we pray that those in position of authority will, as need we all, read the book and be persuaded by the Spirit to believe what it teaches. We pray that they will confess their sin, believe on the Lord Jesus Christ, and live their lives and exercise their authority to the glory of the Lord God. Finally we pray that all who profess love for Scripture will read it and respect the Lord and His Word. We pray that the ultimate purpose of Scripture will be accomplished in their life that they through "the patience and comfort of the Scriptures might have hope" (Romans 15:4).
