General Fund – Offerings this month were \$53,674 vs disbursements of \$99,250, a negative start to a new fiscal year, not unusual for summer months. The budgets of the Trustees, Regents, Missions, & Ed & Publications count on their major funding from your CLC General Fund offerings.

- **ILC Operations—** ILC July revenue was \$74,375 vs disbursements of \$110,347, this beginning deficit not unusual for a summer month when ILC is not in session. The opening of the new school year Aug. 26 will cover the July deficit with student revenues due in Aug.
- **ILC Building Projects** Offerings were \$1,175 vs a disbursement of \$8,000 for the AC/North Hall monthly loan payment.
- **CEF** July revenue was \$75,079 from CEF congregational loan repayments (including an early loan payoff of \$39,000) vs disbursements of \$3,311 for CEF monthly administrative expenses.
- **MDF** –Offerings were \$3,743 vs disbursements of \$15,857, including \$10,000 assistance for Congo Bible School construction, \$2,500 for church building assistance, \$1,310 for foreign pastor motor bikes, and \$400 for Africa exploratory work.
- **SAF** Revenue of \$56,353 (including a bequest of \$47,600) vs disbursements of \$10,453 which was mostly for payments of scholarships & grants for the 1st month of the new school year.
- **Kinship** Offerings of \$5,322 (incl. \$3,120 from sponsors) vs disbursements of \$15,240, including \$7,610 for orphans and \$7,550 for Foreign Seminary & Bible School students.
- **Reserve** Opening Balance 7/1/18: \$298,855; Net disbursement of \$20,767 to cover General Fund FY19 shortfall; Closing Balance 7/31/19: \$278,088.

### After-Word

#### "AN UNEXPECTED ENDING"

Read Luke 18:9-14

Many expected God to praise the Pharisee and to condemn the tax collector. Only, that's not what happened.

Have you ever read a novel with a completely unexpected ending; an ending that left you stunned, shaking your head, and thinking, "I never saw that coming"?

Perhaps the people who heard Jesus tell the *Parable of the Pharisee and Tax Collector* felt exactly the same. Most were likely Pharisees; as Luke described them, "some who were confident in their own righteousness and looked down on everybody else."



As such, they were no doubt thrilled with the premise of the parable; two men praying in the temple, one a Pharisee, the other a tax collector. From their perspective, any story about a Pharisee would have to be a good story with a good ending, in which the Pharisee was praised and the tax collector was condemned.

Only, that's not how the parable ended. According to Jesus, the tax collector "went home justified before God." And at this, the listeners were stunned, disappointed, even angry. "What?" they thought. "How could this be? This was not the ending we expected." Of course, they did not expect this ending, because they did not expect God to reject the religious Pharisee and to forgive the sinful tax collector. But He did.

God's ways are not our ways. And His way to salvation is very different from Man's way. In the unexpected ending of His parable, Jesus taught that salvation is not based on who we are, but on who God is-not on our works, but on God's redemptive work in Jesus Christ.

#### Not Us, But Him

Pharisees were the religious elite in Israel: church-goers, alms-givers, law-keepers; concerned about every 'jot' and 'tittle' of the Mosaic Law, but often ignoring its intent and essence; able to 'strain out a gnat and swallow a camel.'

The Pharisees viewed themselves as a "cut above the rest;" as implied by the name Pharisee itself-from the Hebrew word PAR-

ASH, meaning 'separated one.' "God, I thank You that I am not like other men," said the Pharisee in the parable.

If the Pharisee represented society's best, the tax collector represented the worst. Most tax collectors in Judea were Jews employed by the Roman government; and therefore viewed as collaborators, traitors, and even idolaters. At the time of Jesus, tax collectors were permitted to use any method they chose, and to collect any amount they desired, as long as the Roman government received its share. Abuse was rampant.

Simply put, the Pharisee in the parable was the 'good guy,' and the tax collector was the 'bad guy.' Yet, it was the latter, not the former, who After Word went home justified. Why? God's definition of good is very different from Man's definition. And when it comes to salvation, Man's good is never good enough. As the psalmist wrote, "there is no one who does good, not even one." Not even a Pharisee.

Our salvation is not based on who we are, but on who God is. The tax collector in the parable understood this; while ironically, the religious Pharisee did not. The Pharisee expected God to save him because he was a good person. The tax collector believed God would save him despite his having been a bad person. Why? Because he knew who God is – the gracious, merciful God who forgives even the worst of sinners, when they turn to Him in humility, repentance, and faith.

#### Not Our Works, Not Our Works, But His

But His According to one source, there are more than 4,200 religions in the world today. Yet, of all these religions, only one teaches that Man cannot save himself; that salvation is not by works but by grace, not by doing but by simply believing in Jesus Christ as Lord and Savior. That one religion, of course, is Christianity, as taught by the Bible.

Salvation by works makes perfect sense to human reason and human nature. As human beings, we must work for everything else-work to eat; work to pay bills; work to enrich a troubled marriage. "Hi-ho, hi-ho, it's off to work we go."

So, why can't our good works justify us before God? Because we are sinful by nature. Because, as Isaiah wrote, "All of us have become like one who is unclean, and all our righteous acts are like filthy rags."

Salvation by works was the approach of the Pharisee. Standing in the spotlight of his self-righteousness, he boasted about his good works: "I fast twice a week," he said, "and give a tenth of all I get." Admirable? Yes, but not 'savable;' that is, not able to save. For despite all his good deeds, the Pharisee did not go home justified before God; the tax collector did. An unexpected ending.

In Christ's remarkable parable, the Pharisee is not only an example of how our good character can never be good enough to save us; but also how our good works-regardless of quantity or quality-can never justify us before Almighty God. As Paul wrote to the Galatians: "So we, too, have put our faith in Christ Jesus that we may be justified by faith in Christ and not by observing the law, because by observing the law no one will be justified."

So, through faith in Christ, we poor sinners also have an unexpected ending; a glorious ending that we had no right or reason to expect: the forgiveness of sins and eternal salvation. And that is one unexpected ending that will never disappoint us.
